Abstract

loyd Jones is a famous New Zealand writer, whose writings are generally more inclined to the idea of escapism. A lot of his writings like, *Here At the End of the World We Learn to Dance* and *Paint Your Wife*, displays the characters going into an imaginary world to find solace there. And often the settings of the novels are his homeland. Same is the case of *Mister Pip*. Mister Pip is set around on the island of Bougainville against the backdrop of Civil War of 1990s. Mister Pip tells a story of a black young girl. The novel is first person narrative. So through Matilda, the protagonist of the novel, the reader gets the knowledge of the environment which she lives in, the circumstances i.e. the ongoing civil war and its effects, and how in these state of affairs she got in touch with Mister Watt, the only white person left on the island, who have decided to teach the children of the island.

It was very frequent for them to come and disturb their lives, by pervading terror. It is witnessed in the novel many a times. Here Lloyd Jones portrays a very distressful sight of the killing and the anarchy, imposed by the soldiers. Because of this ever present turmoil and the escalating terror of the War, all the non-natives decided to leave the island before the blocked was imposed. And now the islanders have no contact with the outside world. Surprisingly there is one white man, Mister Watt who has not left the island yet. Mister Watt is a dubious character of the novel. His behavior and his nature are a little odd to the natives.

Mister Watt was a single white man left on the island. So natives were a little suspicious about him in the beginning. His way to talk and dressing sense were a little different from the rest of them. Also his behavior was a little weird. Sometimes he could be seen wearing a big red clown nose, pushing a trolley with her wife in that trolley. He seldom talks with the natives. That's why when he decides to educate the children, their community difference becomes a barrier in this venture. But still he tries very hard to win the hearts of the islanders and to educate the children, though his main aim is to divert the minds of the kids from the throes of war, not, to educate them in conventional manner.

Mister Watt was not a conventional teacher. He himself once said

I want you to understand something. I am no teacher, but I will do my best. That's my promise to you children. I believe, with your parent's help, we can make a difference to our lives.

But he was very much familiar with the novel Great Expectations, and that was the main thing that he taught the children. Gradually the kids started to relate to the main characters of the novel. Through the voice of Matilda, the reader get to know that how she started thinking about Mister Pip, the protagonist of the novel Great Expectations, as a real person. Though she knew that he is just a fictional character but she started having sentiments about him. That can be traced in the following lines from the novel.
